<u>YEAR</u>	<u>EVENT</u>
	Indian Tribes Sauk, Fox, Osage, Missouri, Kansa, Oto, etc.
1673	Pere Marquette & Joliet followed by La Salle down Mississippi
1700	Fur Trade Primarily French fur traders
1733	First white settlement at "Old Charrette Village". Made up of French trappers and traders. Actual site unknown.
1754	French and Indian War
1762	French cede territory to Spain
1767	Spanish attempt to keep the English out
1775	American Revolution (1775-1783)
Unknown	Indian Phillip, Choterau (Choteau), and Lazio secured Spanish grants for large tracts of land located in St. Charles and Warren County. <i>(Not documented)</i>
1795-1799	Americans move into the territory Daniel Boone agrees to bring settlers into Missouri. Settles in the Marthasville area.
1803	Spanish to French to U.S. - Louisiana Purchase
1804	Lewis and Clark Expedition Expedition began in May 1804 and ended in September 1806
1812	Flanders Callaway purchases tracts of land from Phillip, Choteau and Lazio <i>(not documented. Possibly 1022.5 acres in then Montgomery County.)</i>
1812	War of 1812 (1812-1815) Fort Kennedy - 8 miles east of Warrenton. Settled by Thomas Kennedy in 1809
1812	St. Charles County is the first American county west of the Mississippi
1818	Montgomery County is set off from St. Charles County
1821	Missouri becomes a State. Missouri Compromise - Missouri enters Union as a Slave State

<u>YEAR</u>	<u>EVENT</u>
1824	Godfried Duden lived in along Lake Creek. Returned to Germany in 1824. Farm adjoined the town of Dutzow
1830	Daniel and Sally Hankins purchase land (40 acres) - Possibly from Flanders Calloway (<i>not documented</i>) Owned land from prior to 1830-1840
1832	Black Hawk War
1832	Berlin Group from Germany arrives in Marthasville
1833	Warren County is set off from Montgomery County
1837	Panic of 1837 (lasted 7 years)
1837	Small Pox Epidemic - Great Plains
1839	Hickory Grove Township is set off from Elkhorn Township
1840	Asa and Nancy Hinds purchase land (40 acres) from Daniel and Sally Hankins for \$300 Owned land from 1840-1843
1840	The German immigration increases
1842	Harmony Church established.
1846	Mexican-American War (1846-1848)
1848	Herman Christopher Bottemueller purchases land from Asa and Nancy Hinds for \$200 Owned land from 1848-1855
1849	Cholera Epidemic
1851	Cholera Epidemic
1852	Casper Bottemueller inherits land from his father, Herman Christopher Bottemueller Owned land from 1852-1855
1855	Mary Wilhelmina purchases land from Casper for \$500. She marries August Wehmeyer. Owned land for from Jan 1855-Feb 1855
1855	Frederick Mische of Marthasville purchased land (80 acres) from August and Wilhelminia Wehmeyer Owned land from 1855-1864 Cabin land owners were absentee landlords after this time. Cabin housed workers and their families.
1855	Yellow Fever Epidemic
1857	Influenza Epidemic

<u>YEAR</u>	<u>EVENT</u>
	Ran from 1857 through 1859
1860	Approximately 242 slaves in Hickory Grove, Warren, Missouri in 1860
1860	Henry and Catherine Baracker living in cabin with Herman Mische (28) & Henry Osela (25)
1861	American Civil War (1861-1864)
1863	Wright City Raid
1864	Henry and Charlotte Rahe purchased land (part of 240 acres) from Frederick Mische for \$1,400. Owned land from 1864-1904
1865	Typhoid and Cholera Epidemic Ran from 1865 through 1873
1873	Panic of 1873 (lasted 6 years)
1898	Spanish-American War
1899	Phillipine-American War (1899-1901)
1904	William H. and Mary Fricke purchased land (360 acres) from Charlotte Rahe for \$2,500 Owned land from 1904-1908
1908	Robert H. and Nellie Bailey purchased land (360 acres) from William Fricke for \$3,000 Owned land for two days
1908	August R. and Caroline Hoffman purchased land from Robert Bailey in August 1908 Owned land from 1908-1913
1910	Border War (1910-1919) with Mexico and Germany
1913	Louis H. Biermann purchased land from August Hoffman Owned land from 1913-1915
1915	Albert May purchased land from Louis Biermann Owned land from 1915-1928. He defaulted on payments.
1916	Polio Epidemic
1917	World War I (1917-1918)
1918	Spanish Influenza Pandemic
1928	Farmer's and Merchant's Bank owned land. It was sold at auction on the Warren County Courthouse steps.
1928	Harry Hampe purchased land

<u>YEAR</u>	<u>EVENT</u>
	Owned land from 1928-1932
1929	Great Depression (lasted 10 years)
1932	George and Elsie Hummel purchased land from Harry Hampe Owned land from 1932-1935
1935	George Hummel conveyed the land in equal shares to Evelyn and Bernice Hummel Owned land from 1935-1946
1941	World War II (1941-1945)
1946	Thomas and Bernice Quinn purchased land (400 acres) from Evelyn and Bernice Hummel Owned land from 1946-1997
1950	Korean War (1950-1953)
1953	Second Indochina War (1953-1975) - Vietnam
1997	Innsbrook Corporation purchased land (327.57 acres) from the estate of Thomas Quinn
2009	The property on which the cabin stands and the immediate area is deeded to the Innsbrook Historical Society by the Innsbrook Corporation
